Gold Seal Chapter Award Internship Project

The Gold Seal Chapter Award of Merit recognizes outstanding local chapters from across California that achieve the goals of FBLA. These exemplary local chapters demonstrate the FBLA crest of Service, Education, Progress, Education. All active chapters may apply for the Gold Seal Award, but only the top fifteen percent of the total number of local chapters can earn this prestigious award.

Local chapters must follow the guidelines on the Program of Work Progress form and submit the (POW) Progress form to their Section Directors. Chapters must send at least five POW Progress Forms to their Section advisers. Local Chapters must pay section, state, and national dues by October 20 for at least five members. In addition, chapters must show their initiative by recruiting/renewing the memberships of five professional members by February 1. Chapters must host two business tours, invited businesspersons and professionals to speak/be involved in at least two chapter events, conducted a public relations program in its school and community, and submitted five members for Business Achievement Award. Chapters must complete the Government Awareness Project, at least one additional State Project, and achieve the Outstanding Chapter level of each section of the POW. The compiled POW Progress Form must be sent to the State Officers' Adviser. The final POW form must be attached to the outside front cover of a copy of the Local Chapter Annual Business Report and mailed to the chapter's Section Director. In addition, three copies of the report must be sent to the FBLA State Leadership Conference Chair by the same date.

The Gold Seal Award distinguishes the top chapters in California. Ribbons are awarded to qualifying chapters at both he State and National Level. Help show that your chapter is the best and participate in this year's Goal Seal Award!

Companies contact counselors whenever they are in need of student help, so make sure to send your administrators a friendly email of inquiry. Take the initiative and email – or even better, call – companies and ask if they are interested in a part-time, enthusiastic student. Lastly, it is important to talk with your parents and ask for their companies, who often are happy to oblige to their employees' requests, for a job shadow, which can easily grow into an internship. There are many ways to obtain a job, but it is up to you to take the initiative and continue pursuing your fields of interest. There is no better way to avoid the common catch 22--no work experience means no work and no work means no work experience--when transitioning from school to work!
