Important: State and Section Office Applications

Attention California FBLA members, the application for 2013-2014 state and section office is now posted on the State Leadership Team Tab. Your State Executive Board looks forward to reviewing your applications. Applications are due by January 18th for Section President Candidates and March 5th for candidates for all other positions.

Every state position varies in their duties, and each one is integral in helping maintain California FBLA as a whole. Most importantly, state officers serve as liaisons for CAFBLA members to get their questions and concerns answered in a timely and efficient manner.

State officers are also in charge of leading workshops and events at his or her respective Leadership Development Institute, as well as the State Leadership Summit, Officer Adviser Training Day, Section Leadership Conference, and State Leadership Conference.

A candidate's local chapter adviser is required to attend the State Leadership Summit, Leadership Development Institute, Officer and Adviser Training Day, the Section Leadership Conference, State Leadership Conference, and all three State Executive Board Meetings throughout the year. An adviser's inability to attend any of the aforementioned events may result in the officer's termination.

Becoming a State Officer is the best way to further immerse oneself in the journey that is FBLA. On behalf of the state team, all members are encouraged to take this next step in Pioneering Possibilities together
